

Annual Raffle 2024 Terms and Conditions

By purchasing a raffle ticket, the purchaser agrees to be bound by these terms and conditions:

The raffle is being promoted by Brightly, a charity that is registered with the Jersey Charity Commissioner, registration number 152

- 1. There are 13 prizes.
- 2. All those affiliated with Brightly are permitted to purchase tickets except the Promoter, Wendy Nerac, Fundraiser.
- 3. The tickets will be numbered from 0001 to 2000.
- 4. Tickets must be purchased by adults aged 18 years old or over. Any ticket purchaser found to be under 18 years of age automatically forfeits the right to claim a prize, which will revert to Brightly.
- 5. Only tickets for which full payment has been received at the date of the draw may be entered into the draw and eligible to win a prize.
- 6. Only one name should be entered as the ticket purchaser and will be recorded against the number on the ticket purchased. Any winnings will only be paid to that person under the terms and conditions.
- 7. The ticket purchaser is responsible for providing Brightly with accurate and up-to-date contact details, including their name, email address, and/or telephone number. The ticket purchaser shall inform Brightly of any changes to these details as soon as they arise. Brightly will be in no way liable for the failure or inability to contact a ticket purchaser due to any errors, omissions, or inaccuracies in the information provided by the ticket purchaser.
- 8. Tickets for the raffle are non-transferable.
- The draw will take place on Friday 14th June 2024 at 10am at 1 Leighton Court, St Aubins Road, St Helier.

- 10. Brightly reserves the right to alter the nature of the draw and to change the venue of the draw but not the date or time. Brightly shall endeavour to notify all ticket purchasers of any change to the venue through our website <u>www.brightly.je</u> or facebook.com/BrightlyJersey.
- 11. The prizes will be drawn with the top prize to be won by the first ticket drawn. The ticket number of the winner will only be announced not the winner's name.
- 12. The winners will only be given the prizes that they win.
- 13. Any unsold tickets will not be entered into the draw.
- 14. Ticket sales will cease **on Friday 31**st **May 2024 at 4pm** or when all tickets have been sold, whichever occurs first.
- 15. The Promoter will ensure that the draw is conducted fairly and in front of witnesses.
- 16. The Promoter will publish the results of the draw on Brightly's website <u>www.brightly.je</u> and Facebook page facebook.com/BrightlyJersey.
- 17. If someone has won a prize and is not in attendance at the venue when the actual draw takes place, the prize will be put aside for that person and there will be no redraw.
- 18. If any prizes are unclaimed on the day, the Promoter will contact all the individual winners personally to arrange collection or delivery on **Monday 17th June 2024** or you can call the promoter on 07797 856 127 to arrange collection or delivery.
- 19. The Promoter will ensure that records are kept showing monies received from the sale of tickets, details of who bought the tickets, and proof that prizes were distributed or paid out to the winners.
- 20. The Promoter will also ensure that financial records are kept of income and expenditure, including administration expenses such as printing of tickets, the value of donated prizes, and purchase of prizes.
- 21. The Promoter will ensure that records are kept for one month after all prizes have been paid out. If not, all prizes are claimed on the day of the draw, they will be retained along with the records for a minimum of six months. A record of how they are then disbursed will be retained.
- 22. Any ticket purchased in breach of these terms and conditions will be voidable at the sole discretion of Brightly.
- 23. Any complaints relating to the draw should be made in writing to the Chief Executive, Brightly, Larn-a-Lod, Rue du Coin, Grouville, Jersey, JE3 9QR. Any decision that is made under these terms and conditions shall be final and binding.
- 24. Brightly raffle is regulated by the Jersey Gambling Commission (JGC) under permit number **#CR2286-24**
